Please ensure all sections of the form are completed and signed, where required, to ensure your application can be properly considered. (The council may require proof of occupancy and liability for council rates)

The consent of the owner(s) must be attached (or below), unless council rate notices are addressed directly to the occupiers, or unless owner approval was previously given and this application is only a renewal.

Additional Notes:

No more than two owners, or two occupiers, may be enrolled for a single rateable property.

The person appointed by the corporation:

- must be a company secretary or director of the corporation.
- must be at least 18 years of age by the election day,
- must not be otherwise entitled to be enrolled to vote in the municipality as a resident, property owner, property occupier or representative of another corporation.

This enrolment is only valid for one term of the council. If the corporation continues to occupy rateable property it may reapply to appoint a voting representative before that election.
