Privacy Notification: The information provided on this form is subject to Section 18 of the Domestic Animals Act 1994 and will be used to update the public animals register as prescribed under that Act.

YOUR RESPONSIBILITIES AS THE OWNER OF A DOG OR CAT

- * Proof of microchipping is required for all new animal registrations.
- * All dogs must be securely confined to your property and wear their registration tags at all times.
- * Dogs must be leashed at all times within the Borough of Queenscliffe unless being exercised in a designated 'off leash' area.
- * Your dog or cat must not cause a nuisance.
- * Your dog or cat must wear the Registration Tag provided at all times, to ensure ownership of the animal can be quickly traced.
- * If a dog rushes at or chases any person the owner is guilty of an offence.
- * CATS must be securely confined to their owners premises between 8.00pm (eastern standard time) or 9.00pm (daylight saving time) and 6.00am daily penalty up to \$727.00.
- * CATS (other than restrained domestic cats) are prohibited in public areas in the municipality.
- All cats must be desexed prior to registration as required by the Domestic Animals Act.
- * All cats and dogs over three months must be registered.
- * It is the responsibility of the dog owner to remove and dispose of their dogs waste when in public places.
