- * Under the Provisions of the Domestic Animal Act, 1994, all dogs and cats over the age of three months must be registered and be re-registered by the 10th April each year - Penalty up to \$3304 (as at 1/2/2021).
- * Current Registered Organisation membership card must be produced each year.
- * Signature of Owner is required - if the owner is under 18 years of age a parent/guardian is required to sign the form.

<p style="text-align: center;">YOUR RESPONSIBILITIES AS THE OWNER OF A DOG OR CAT</p> <ul style="list-style-type: none"> * Proof of microchipping is required for all new animal registrations. * All dogs must be securely confined to your property and wear their registration tags at all times. * Dogs must be leashed at all times within the Borough of Queenscliffe unless being exercised in a designated 'off leash' area. * Your dog or cat must not cause a nuisance. * Your dog or cat must wear the Registration Tag provided at all times, to ensure ownership of the animal can be quickly traced. * If a dog rushes at or chases any person the owner is guilty of an offence. * CATS must be securely confined to their owners premises between 8.00pm (eastern standard time) or 9.00pm (daylight saving time) and 6.00am daily - penalty up to \$661.00. * CATS (other than restrained domestic cats) are prohibited in public areas in the municipality. * All cats must be desexed prior to registration as required by the Domestic Animals Act. * All cats and dogs over three months must be registered. * It is the responsibility of the dog owner to remove and dispose of their dogs waste when in public places.
