#### Safer roads for pedestrians

Locals and visitors to the Borough of Queenscliffe are set for a safer transport experience with Council recently completing a pedestrian safety blitz across Queenscliff and Point Lonsdale.

Increasing pedestrian safety and reducing driver confusion along Hesse Street, Queenscliff were common concerns raised by residents during a Borough of Queenscliffe road safety consultation last year. We've responded by installing two new pedestrian-priority crossings in Hesse Street and reducing the speed limit to 40km/h, making it easier and safer for those on foot to navigate the street.

Other road safety improvements undertaken in the Borough include new pedestrian crossings on Point Lonsdale Road and Ocean Road in Point Lonsdale, a new pedestrian crossing on Gellibrand Street in Queenscliff, and traffic refuges on King Street and Flinders Street in Queenscliff. Each of those improvements is a direct response to the feedback we've heard about how we could make it safer to get around the Borough on foot.

Council's recent improvements are supported by various funding programs, including the Transport Accident Commission and the Australian Government.

### Borough looks ahead with new Community Vision adopted

Volunteer community representatives from Queenscliff and Point Lonsdale have worked hand-in-hand with Councillors to develop a new ten-year vision for the Borough of Queenscliffe, which was formally adopted by at August's Ordinary Council Meeting.

A requirement of the Victorian Government's recently introduced Local Government Act 2020, the Community Vision describes our community's aspirations for the future of the Borough. The document was developed in partnership with the community, and will be used to guide strategic

The five-pillar format was chosen by the panel for its ability to both highlight areas of specific importance and to synthesise these values into a central vision.

## Borough takes the honours in Mayoral vaccination challenge with Buloke Shire

The Borough of Queenscliffe and Buloke Shire's respective Mayors took part in a good-natured challenge across September as part of a vaccination blitz to see which Council area could be first to reach the 80% fully vaccinated milestone.

At the time of announcing the challenge, the two local government areas were first and second respectively in two-dose vaccination rates across the state. Queenscliffe Mayor Cr Ross Ebbels and Buloke Mayor Cr Daryl Warren,

old friends themselves, decided that the losing Mayor would agree to host the winning Mayor for dinner and a night's accommodation in their home town when restrictions allow.

The challenge officially concluded in late
September when Queenscliffe became the first
LGA in Victoria, and indeed Australia, to pass
the 80% fully vaccinated mark. The two Mayors
caught up virtually to thank their communities
and make good on the terms of their bet –
Mayor Warren of Buloke Shire will be treating

Mayor Ebbels of Queenscliff to a meal and a night's accommodation in the coming months.

Since then, both LGAs have continued their outstanding vaccination rates with each Council reaching a >95% first dose rate in October. Thank you to all of our residents who have made our community safer by getting vaccinated. ## Tourist park operations review underway

A draft tourist parks management strategy is just weeks away from release following extensive consultation from Council on how to make the Borough's suite of caravan parks more financially sustainable and competitive into the future.

Some of the changes being investigated by Council include operational improvements, new services and facilities, and opportunities to increase visitation in the winter months.

This is in addition to the existing benefits of Council's tourist parks, including affordable visitor accommodation, generation of income, and attracting new customers and clients to support local businesses.

Consultation took place throughout August 2021, with a draft strategy and second round of consultation planned for release in the coming weeks before the final strategy is considered for adoption by Council in the months following.

## Share your ideas for a new sustainable waste facility

The Borough of Queenscliffe is partnering with Barwon Water and five other regional councils to develop an innovative new waste facility that turns food and garden waste into useable products.

The Renewable Organics Network Facility project, developed in response to rising waste costs and capacity constraints, is expected to process 40,000 tonnes of organic waste each year. Using a combination of bacterial digestion and heat treatment, this processing would turn the waste into renewable energy and high-quality compost and fertiliser products which can then be sold to offset rising waste costs. The facility is expected to reduce carbon dioxide emissions from our region's waste processes by up to 15,000 tonnes every a year, while generating

enough electricity to power 500 homes.

While the benefits of the project are clear, the Borough of Queenscliffe and Barwon Water are seeking community input to further develop the concept and ensure residents play a role in shaping the future of the region's waste management. Consultation is now open for the project, and residents can learn more and share their ideas at yoursay. barwonwater.vic.gov.au/ron, with feedback closing on 26 November 2021.

While the project is innovative in both scale and scope, the Renewable Organics Network would be built using proven technology.

Barwon Water has successfully demonstrated the concept on a smaller scale at its Colac Water Reclamation Plant, which takes organic waste from local industry and converts it into enough renewable energy to take the plant entirely off the grid. #### Foghorn shed restored

Point Lonsdale's heritage-listed foghorn shed is looking better than ever after it received a refurbishment and restoration during late September. The project restored old and yellowing weatherboards to give the historically significant shed a crisp coat of white and grey ahead of the summer months.

Council invested \$50,000 in refurbishment works to restore the shed to its former glory, which required replacement of rotten and damaged weatherboards, internal and external paint removal and repainting, and other upgrades.

The shed, first built in 1928 to replace the previous foghorn shed at the same location, was listed in the Victorian Heritage Register in December 2019 as part of a larger operation to protect the entire Point Lonsdale Maritime and Defence Precinct.

### Pandemic hardship policy extended

Council has recently extended the availability of its COVID-19 Financial Hardship policy. In recognising that the pandemic has and will continue to cause significant financial hardship for some members of the community, we're continuing to help the residents, ratepayers and businesses which need that assistance. The policy was introduced in April 2020 and has helped numerous recipients with financial certainty in what are uncertain times.

## Queenscliff Town Hall to see major upgrades

Queenscliff Music Festival (QMF) and the Borough of Queenscliffe have announced a new partnership to upgrade the Queenscliff Town Hall to become a highquality creative space.

QMF has secured two grants to undertake the first stage of an upgrade to the Hall that will include new sound and lighting systems, a screen and projector, and better marketing for the venue. Combined, these upgrades will allow the Town Hall to support a broader range of performances. The project is being managed under a governance structure that includes

Council officers and QMF representatives working together and meeting regularly for several months.

The project will provide extensive benefits for existing and new users of the Hall including community groups, schools, local creatives, and community events like the Bellarine Lighthouse Film Festival and Queenscliffe Literary Festival. Improved facilities are part of Council's ongoing focus on enhancing the Borough of Queenscliffe's reputation as a regional arts and culture destination, and will assist in securing new events that could attract hundreds of visitors.
