NEW COUNCILLOR APPOINTED

Rob Minty was elected as Councillor for the Borough of Queenscliffe after the Victorian Electoral Commission held a virtual countback in June.

The vacancy on the Borough's five-person Council occurred following Cr Fleur Hewitt's resignation in May. In an online presentation which Council broadcast in the Queenscliff Town Hall, the VEC ran the election and advised that the redistribution of Cr Hewitt's preferences would see Cr Minty elected.

The VEC confirmed Cr Minty's eligibility for the role and he was invested in a ceremony held by the Borough of Queenscliffe. This is Cr Minty's second term with the Borough after he previously served as Councillor in 2019 through until the end of term in October 2020.

At the swearing-in ceremony, Mayor Tolhurst said "Council welcomes Rob Minty back to the Borough of Queenscliffe Council. We look forward to his contributions in the chamber and wish him well for the remainder of the term."

2023–24 Community Grants

Twelve local community groups and organisations from across Queenscliff and Point Lonsdale have been awarded a combined \$18,682 in grant funding as part of the Borough of Queenscliffe's 2023–24 community grants program.

The community grants were announced at a presentation evening held at the Wirrng Wirrng (Queenscliffe Hub) in August, where Queenscliffe Mayor Isabelle Tolhurst, along with Cr Ebbels, delivered the good news to a delighted crowd of attendees.

Non-resident property owners now required to apply for placement on voter roll

Changes have been made to voter entitlements in the Local Government

The most significant change for the 2024 Local Government elections is that all property owners not enrolled on the State roll will need to apply to be enrolled if they wish to vote. This means non-resident owners of residential properties will now be required to apply to be placed on the voter role ahead of the 2024 elections.

Council will send a notice to voters who were enrolled on the last voters' roll under section 243 of the Act, advising that their enrolment expires before the next general election. We will invite affected ratepayers to renew their enrolment by the close of the roll if still entitled.

This year's theme 'Be a Voice for Generations', encouraged all Australians to be a voice for reconciliation in our everyday lives – where we live, work, and socialise. Mayor Tolhurst and Cr Ebbels, along with Council officers, local school children, and interested community members, came together to recognise our shared histories and to reflect on listening, learning, and walking together with First Nations Communities.

The Smoking Ceremony was conducted by proud Wadawurrung woman Corrina Eccles who spoke beautifully of the rich Indigenous history in the Borough and led the children in a First Nations song.

Electric Vehicle Fast Chargers Now Charging!

The wait is over, our new electric vehicle chargers have been installed at 50 Learmonth St and are now ready for public use.

These fast chargers can fully charge a car in approximately 40 to 90 minutes – nearly 10 times faster than traditional EV chargers. This is a great service for electric vehicle drivers as they can charge their car while enjoying all Queenscliff has to offer.

Our EV fast chargers operate on a userpay arrangement at a rate of 45¢ per kilowatt, paid through the Chargefox app. The chargers supply renewable energy sourced from wind through a power purchase agreement with the Victorian Energy Collaboration.

Promoting the use of electric vehicles ties in closely with 'Pillar 4: Sustainable Transport' in our Climate Emergency Response Plan. The Victorian Government's Department of Energy, Environment, and Climate Action (DEECA) supported the installation of the chargers through the Destination Charging Across Victoria Program and the EV Charging for Council Fleets Program.

Putting Queenscliffe on the EV map makes the Borough a convenient stop for electric car owners, not only benefitting businesses and tourists but our community and planet as well.

COMMUNITY CONVERSATION ON THE VOICE

At the March 2023 Ordinary Meeting, Council resolved to facilitate a community conversation on the upcoming referendum on the Voice to Parliament.

The Borough of Queenscliffe, in conjunction with Point Lonsdale Civic Association, and the Queenscliffe Reconciliation Mob, hosted the community conversation event at the Point Lonsdale Primary School Hall on August 13.

After a heartfelt Welcome to Country by Wadawurrung woman Corrina Eccles, Mayor Tolhurst opened the event.

'Today we seek to explore and understand what the proposed Voice to Parliament means for First Nations people and Australian society as a whole. This is a community conversation, not a debate, featuring the perspectives of people close to the process, knowledgeable about its design, and deeply affected by the proposal.' said Mayor Tolhurst, who went on to say 'Local government has the privilege

of being the closest arm of government to people. As a result, we have a duty to talk with our community about issues of significance.'

The speaker line-up included Corrina Eccles, who spoke of the profound importance The Voice to Parliament represents not only for Wadawurrung people but First Nations people across the country. Constitutional lawyer Professor Cheryl Saunders AO shared with the audience details concerning how the proposed alterations will be implemented into the constitution, and journalist Kerry O'Brien spoke of his journey in coming to understand why a First Nations voice in parliament is so critical, now more than ever.

Approximately 140 people attended the event which was live-streamed for those unable to make it in person.
